DRAFT MINUTES

Present: Councillors: Julie Morten (Chair); Cedric Gilbert; Morgan Jackson; Rosie Rumble; DCC Councillor Jim Perkins; HPBC Councillor Sarah Helliwell; Nick Faulks and two members of the public.

This meeting was open to the public unless otherwise stated.

18/11/1 Apologies for absence. PC Graham Mason; Cllr. Tony Favell (Accepted);

18/11/2 Guest Speaker. None.

18/11/3 Declarations of interests. None.

18/11/4 Public speaking – max 10 min.

- DCC Cllr. Perkins stated that any changes to the highways following the Edale meeting could take up to 3 months to facilitate. The Council should now be notified of any official highways closures. It should be noted that a Christmas “Wigwam” in Castleton has been given a licence to open 12:00 to 23:00 (not through DCC) but this should not affect highways.
- It was reported, and visually confirmed, that the parking fees in the HPBC car park are now 24hour. It is unknown when this started.
- HPBC Cllr. Helliwell reported that there is a National Parks Landscapes review and the Council are encouraging everyone to take part. The deadline is 18th December. It is an online questionnaire and can be found at www.gov.uk/government/consultations/landscapes-review-national-parks-and-aonbs-call-for-evidence. Councillors agreed to respond as individuals.
- It was restated that Post Office opening times are Wednesdays 9:15am to 12:15pm
- Following a site meeting with highways, a list of actions and proposals has been received. This list to be given to the parking group. The short term is mainly to make existing signage clearer, the longer term is to get a traffic regulation order (TRO) for 2 hour parking restriction outside the Church. All decisions will come through the Parish Council and the parking group will be kept up to date. Concern was raised about the short term parking outside the Church. Cllr. Perkins responded that due to the spacing of the signage the road markings cannot currently be enforced and this is unlikely to change until the TRO is issued
